Schaeffler Transportation Guide

To achieve prompt transit times and affordable shipping charges, it is important all routing instructions contained in this guide be properly applied. Please communicate and share this information to the individuals in your organization responsible for shipping and carrier selection.

SHIPPING REQUIREMENTS:

1. **SHIPMENT CONSOLIDATION:** Multiple orders to the same destination on the same day must ship on one bill of lading.
2. **P.O. NUMBER:** The Purchase Order Number must appear on the bill of lading and on the shipment label.
3. **FREIGHT CLASSIFICATION:** The bill of lading must show the correct and complete freight description as described in the National Motor Freight Classification, NMFC. If the proper description is not known, please contact the CoLinX Transportation Dept., the proper description will be provided.
4. **FREIGHT CHARGES:** Shipments whereas The Schaeffler Group is responsible for the freight, indicate on the Bill of Lading, "Prepaid," "Bill To" (The respective business unit, i.e. Schaeffler Group (US or Canada) - FAG or INA) c/o CoLinX Freight Payment 1536 Genesis Rd. Crossville, TN 38555: **Freight charges, which are prepaid and added to your invoice, without authorization to do otherwise, will be deducted, and will not be paid. If you prepay and absorb the charges, disregard this item.**
5. **3RD PARTY SHIPMENTS:** Shipments to non-SCHAEFFLER destinations must identify the location directing the shipment as the first line in the ship to address and must also indicate a third party freight billing address on the bill of lading. When directed to ship to a non-SCHAEFFLER location, refer to **Supplier Shipments to Non-SCHAEFFLER USA Destinations** of this guide for detailed instructions.
6. **COLLECT SHIPMENTS:** Although CoLinX carriers may recognize the consignee as a CoLinX managed business unit, we prefer the Bill of Lading to reference collect, if it is a Schaeffler location.

CEP (Parcel):

For shipments with a total shipment weight up to 200 lbs., with no one piece exceeding 70 lbs. (not 150 lbs.), within the United States, please use **UPS Parcel**, within Canada, please use **Loomis**. Between the US and Canada, please use **Federal Express**. The appropriate CEP account number is to be listed on the P.O. If shipping to Laredo by UPS COLINX account number, Laredo will only receive in México urgent shipments with previous instructions.

LTL ROUTING INSTRUCTIONS:

The attached LTL Routing Guide must be used when selecting a carrier to transport shipments which exceed 200 lbs weight limits. LTL mode limitations: weight less than 20,000 lbs. and do not exceed 20 feet of trailer space(are not of a "Full Visible Capacity").

FTL SHIPMENTS EXCEEDING 19,999 LBS:

Shipments which exceed 19,999 lbs. or 20 feet of trailer space may be transported more economically via a truckload carrier. For shipments exceeding this weight contact the CoLinX Transportation Department for routing and or set up at 931-459-5136 or 931-459-5135.

FLATBED SHIPMENTS:

When flatbed service is required, **contact the CoLinX Transportation Department to assist in the setup of the flatbed shipments for the most competitive freight cost.**

AIR FREIGHT:

Premium cost modes may be used only when authorized by the Purchasing, Transportation or Planning department. For all Schaeffler Group NA locations, an approved signed Premium Freight Request (PFR) form must be submitted to CoLinX (domestic) or K+N (international) before shipment is setup with the carriers. **Your contact at CoLinX or K+N will assist in the setup of the air freight shipment to reduce Premium Freight costs. Only approved PFR's by management are authorized to ship Premium air freight.**

When airfreight service is specified one of the following carriers must be used,

- 1: UPS Air CEP (Parcel) US Domestic shipments less than 100 lbs.
- 2: Federal Express CEP (Parcel) International shipments over 100 lbs.
- 3: UPS Air Freight Forwarding – shipments over 100 lbs.

Air Chartered Shipments

Kelly Air is the CoLinX preferred air charter provider. All Schaeffler Group INA locations must contact CoLinX to assist in the negotiating and the set up of any air charter shipment. **Contact CoLinX to assist in the quoting/ set up of air charter shipments to reduce Premium Freight costs. Only approved PFR's by management are authorized to ship air chartered freight.**

GROUND EXPEDITED SHIPMENTS:

Premium cost modes may be used only when authorized by the Purchasing, Transportation or Planning department. For all Schaeffler Group NA locations, an approved Premium Freight Request (PFR) form must be submitted to Plant Shipping departments or CoLinX (domestic) before any expedited shipment can be scheduled with the carrier.

When expedited ground truck service is requested, one of the following preferred carriers must be used.

- Fed Ex Custom Critical 877-525-1263 Pin # 26546
- Bolt 704-655-2654
- RP Expediting LLC 864-592-1122

• **Note: Woodward Trucking is not an authorized Premium freight carrier, they must be approved by CoLinX to control costs.**

Contact CoLinX to assist in the setup of the expedited shipment to reduce Premium Freight costs. Only approved PFR's by management are authorized to ship EXPEDITED ground freight.

Supplier Shipments to Non-Schaeffler USA Destinations

Overview:

It has become a common practice to ship from one supplier to another, with The SCHAEFFLER companies retaining the responsibility for payment of the freight charges. In order to pay the freight bill, we must have a system to determine which facility authorized the shipment to a non-SCHAEFFLER destination. If we are unable to make this determination from the carriers' freight invoice, we will return it to the carrier. By our rejection of the freight invoice, the shipper becomes liable for the freight invoice. In order to avoid these issues, all suppliers must use the following procedure.

Procedure:

When requested to ship to a non-SCHAEFFLER address the bill of lading must be prepared as follows:

1. The first line of the consignee address must identify the facility directing the shipment. For example a request to a supplier by our Cheraw, SC plant to ship to a non-SCHAEFFLER destination would be consigned on the bill of lading as follows:

Consigned To: Schaeffler Group – INA Cheraw
c/o Specialty Steel
12345 Your Street
Fort Mill, SC 29715

2. The freight charges must be billed to our 3rd party address. The following notation must appear on the bill of lading in a conspicuous manner:

Bill Freight Charges To: Schaeffler Group - INA (or the respective company)
c/o CoLinX Freight Payment
1536 Genesis Rd.
Crossville, TN 38555

3. The approved carrier must be used. The SCHAEFFLER companies will incur excessive costs on these shipments, if an unapproved routing is used. To avoid responsibility for these excessive costs the supplier must use the requested routing.
